





## Really United to Tackle Climate Change? A reflection on the COP26 from a global perspective

## Workshop, 3 December 2021, 10.00 to 12.00 a.m. (registration required) Diplomatic Academy Vienna (Musikzimmer), Favoritenstraße 15a, 1040 Vienna

"Uniting the world to tackle climate change" is the motto of the 26<sup>th</sup> UN Climate Change Conference (COP26) in Glasgow. Facing the tremendous challenges of the global health, climate and biodiversity crises – against the background of a looming debt crisis – international solidarity and the strengthening of multilateral cooperation seem more necessary than ever.

Limiting global warming to below 1.5°C above pre-industrial levels will also need a profound transformation of our financial and economic systems. Especially countries of the Global South – who are historically not responsible for climate change but bear the brunt of its effects – will need massive support for climate adaptation, climate mitigation and the necessary transformations of their economies. Climate finance might be one of the most crucial elements to help those countries. But "developed" countries have not yet fulfilled the USD 100 billion target already agreed in 2009. Especially climate adaption measures need an urgent financial ramp up. Moreover, more than 80 % of current finance comes in the form of (non-concessional) loans, leading to additional debt distress in many lower income countries.

At the workshop, we will discuss the outcomes of the COP26, especially with regards to climate financing, and look at possible ways forward.

He took degrees in political science and social management in Vienna.

Ann has led the Jubilee 2000 campaign, which was part of a successful international movement that led to the cancellation of USD 100 billion of debt owed by the poorest countries. Ann was born in South Africa and took her degree in politics and economics at the University of the Witwatersrand in Johannesburg.
